UK NARIC statistics map international student demand trends

UK NARIC is developing a map of the shifting patterns and trends of international student demand, by analysing usage and viewings statistics going back to 2009 for its International Comparisons and other data banks.

The usage statistics give a picture of the countries and qualifications being queried and investigated by admissions officers. Shifts, patterns and trends are being plotted from millions of International Comparisons page views over 6 years, from 2009 to 2015. Data from our Member Enquiry service usage are also being compiled.

A full briefing on the findings will be presented at the forthcoming Emerging Markets Seminar Event Seminar Event in London on 17 February.

As a preview, interesting trends include:

In Europe, consistent significant year-on-year increases from 2011 in usage of our data on Italy (*Florence pictured below*) – and also rises in Member Enquiries about Italy. In the same (more...)
