## UK signs UNESCO Global Convention on Recognition of Qualifications



The UK has ratified the UNESCO Global Convention on the Recognition of Qualifications concerning Higher Education. Susan Acland-Hood, Permanent Secretary at the UK Department for Education, was in Paris [pictured above, right] to deposit the UK's ratification with UNESCO.

Dr Cloud Bai-Yun, Chief Executive of Ecctis, said: 'I am proud that UK ENIC played a leading role in the process that resulted in ratification, along with the UK Department for Education, the Devolved Administrations and the UK National Commission for UNESCO. The Global Convention will have significant impact on the future landscape of world qualifications.'

The Global Convention will create a framework for fair, transparent and non-discriminatory recognition of higher education qualifications, putting in place universal principles for improving recognition practices.

Paul Norris, Head of UK ENIC, says: 'The UK's ratification of the Global Convention is an important illustration of the UK's commitment to best practice in global mobility, and to improving international cooperation on recognition. The UK is one of the first 20 signees of the Convention, so will be one of the originating members of the Convention once it enters into force. In doing so, the UK is sending a strong message to the world, that we believe in transparent and fair recognition of international qualifications within the UK.'

The Convention will also help promote the value of UK qualifications across the world. UK ENIC has played an active role in consultations leading to the UK's ratification of the Convention. These consultations involved the UK Devolved Administrations, the British Crow n Dependencies and Overseas Territories during the course of 2020-21.

Professor Emerita Anne Anderson, Higher Education Commissioner from the UK National Commission for UNESCO, said: 'Achieving UK ratification of the Global Convention on the Recognition of Higher Education Qualifications was a great example of partnership working to achieve an important goal. The expertise and advice of Dr Bai-Yun was invaluable as we in the UK National Commission for UNESCO garnered support
