# New development of UK NARIC's Early Years Service launches 1 September

A development of UK NARIC's Early Years Service will be launched on 1 September. The service assists those with overseas qualifications who are seeking to work in Early Years settings in England.

The Early Years Service is operated in collaboration with the Department for Education, and maps in detail the content of international qualifications to the DfE's qualifications and skills criteria.

Up until now, detailed mapping has been done for Early Years higher level criteria only - Level 3 Early Years Educator. From 1 September, this mapping can now be done for lower level qualifications READ MORE
