Welcome to the December 2017 edition of NARIC News

Over 500 attend UKNARIC17; 2018 dates are 7/8 November, QEII, Westminster

Over 500 delegates attended the UKNARIC17 annual conference in Victoria, London on 20/21 November, our 21st and once again a record-breaking biggest-ever annual conference.

Delegates, speakers, sponsors and exhibitors from more than 30 countries gathered for the two-day event.

Key themes explored included the potential for partnerships and funding in Malaysia and China; the recruitment potential, but also the challenges, in important and growing markets such as Nigeria; addressing the complexities of transnational education, in both FE and HE; opportunities offered by online learning; the latest global developments in digital credentials; the continuing and growing problem of fraud in education, and possible verification and security solutions; and new techniques to engage with applicants, including dealing with the different internet landscape in China.

The dates and venue for the 2018 conference are set: 7 and 8 November, at the QEII Centre, in the heart of London, in Westminster. EU VET survey and funded NEETs/skills initiatives

New articles are available online from UK ReferNet, the portal to the European network for comparable information on vocational education and training (VET).

European Grade Distributions now in new format

In January, the European Grade Distributions (EGD) database is being converted into an online publication for members to access from the Publications tab in the Members' Hub.

The Grades tab on the Hub page will act solely as the gateway to the much larger, global International Grade Comparisons (IGC) data bank, which will be the main focus in future for updating and developing UK NARIC grade comparison data.

To reflect more globalised recruitment planning in modern institutions, we are expanding and upgrading the IGC database to cover 110 countries and 405 qualifications from January 2018. (more...)

Professional recognition is essential for some people where professional status achieved by experience or qualification, such as Chartered Accountant status or Qualified Teacher Status, entitles them to work at a higher level (more...)
