UK NARIC expands sector-specific services: new construction scheme launches

UK NARIC is expanding its range of services for specific occupational sectors with a new construction industry scheme to launch on 2 January.

The new service is designed to meet the needs of the Joint Industry Board for Plumbing Mechanical Engineering Services in England and Wales (JIB-PMES).

JIB-PMES is making it a requirement that holders of overseas qualifications use the UK NARIC Statement of Comparability for Construction Skills service to apply for and obtain one of their CSCS cards. The CSCS card is needed to work on construction sites, and versions of the card are issued by a number of industry bodies.

This extends the scope of the UK NARIC construction service, which the Construction Skills Certification Scheme has already made a requirement for overseas applicants for their CSCS cards.

These UK NARIC services map the skills of overseas qualification holders to UK National Occupational Standards, and also use Primary Source Verification (PSV) to verify that the overseas qualification is genuine. This assists industry bodies in maintaining standards of work and health and safety on construction sites, and in preventing fraudulent applications for cards using fake or altered qualification and training certificates. UK NARIC is managing the project and the project partners are the Dutch NARIC (NUFFIC) and the Czech ENIC-NARIC.


GO-ERP aims to share good practice in recognition, with a particular focus on European recognition practices in a global context, to see if they are transferable and usable internationally. (more...)



ETS and NEEA Start to Map TOEFL® Test Scores to CSE Levels

UK NARIC takes part in ASEM 10th anniversary book

ETS, the developer of the TOEFL® test, joined the National Education Examinations Authority (NEEA) — the Ministry of Education, P.R. China — for a five-day academic workshop in Beijing to map the TOEFL iBT® test scores to the proficiency levels of China's Standards of English Language Ability (CSE).

This mapping is the first step to help Chinese test takers better understand the ETS English-language tests, as well as to promote research on foreign language ability standards and assessments in China.

Representatives from ETS [*pictured above*] attended UKNARIC2018 to discuss recruitment strategies and student flow using insights collected from the ETS TOEFL bank of data. (more...) After two years of research, the project *Employer Engagement in Design and Development of VET* (ED2VET) has produced a portfolio of case studies and an evaluative report accessible on the project website.

ED2VET aimed to investigate the factors that determine the extent and impact of employer involvement in VET design, and identify good practices for sharing.

UK NARIC and project partners from Scotland, Greece and Bulgaria have collected case studies from European countries where employers have participated in the design and development process of vocational education and training. (more...) UK NARIC has contributed to a new hardback book celebrating 10 years of the Asia-Europe education process. Looking Back and Looking Ahead: The ASEM Education Process - History and Vision 2008-2018 discusses the education process from the different perspectives of the editors and various authors from ASEM members and stakeholders.

UK NARIC CEO Dr Cloud Bai-Yun made two contributions to the publication. Cloud is one of the founding members of the Asia-Europe ASEM Education Process Bridging Declaration.
