## Charting the impact of COVID-19 on education: latest updates



The UK ENIC research team continues to track announcements on school closures and exam arrangements worldwide, on our Charting the impact of COVID-19 blog.

The latest figures from UNESCO reveal that schools are closed nationwide in 6 countries. This figure has fallen and is the low est number since March 2020.

How ever, there are many countries in which schools are now closed for the holidays. Notably in Southern Africa, where cases have increased recently due to the Omicron variant.

Measures that are in place for South African schools remain unchanged and schools opening is dependent on number of cases locally. Students in some schools attend in shifts or on rotation.


This session was a great introduction and enhancement of know ledge for organisations worldwide on how the structure and assessments are conducted within offshore medical schools in the West Indies.

The conference examined the priorities and next steps for the UK's Transnational Education (TNE) provision and exports in light of COVID-19 and the UK leaving the EU.

The first part of the conference focused on quality assurance, regulation and recognition. Delegates heard from the Office for Students about their plans to strengthen their international engagement with counterpart bodies to support the quality assurance of English TNE, and developments regarding the voluntary Quality Enhancement scheme for UK TNE run by the Quality Assurance Agency.
