#### Over 450 UKENIC23 conference delegates hear Minister's keynote address



Over 450 delegates, from 25 countries, attended our two-day UKENIC23 annual conference in Westminster, London this month.

With an overall theme of 'Reconfiguration', the event featured over 50 sessions, and a total of 120 speakers, including a keynote address from Rt Hon Robert Halfon MP, UK Minister for Skills, Apprenticeships and Higher Education.

'We need to be adaptable and responsive,' he told delegates. 'We cannot just hope that the world will become different on its own. Education is all about opportunity.'

Ajaz Ahmed, CEO of design and innovation company AKQA, also took part in the opening plenary session, alongside Tom Bewick, CEO of Ecctis, the Employee-Ownership Trust (EOT) which operates and manages UK ENIC.



UK ENIC attended more refugee employability events last month, as part of our ongoing support for refugees and people in refugee-like situations who need advice and information to access further study or employment.

Alina Davodova, UK ENIC Senior Information Officer, and Maria Artamonova, Information Officer, provided face-to-face support to over 200 people at two events, explaining how we can support them with qualification recognition, and giving advice to those with missing or partial documentation.

An event in Evesham focused on supporting people from Ukraine, with many attendees receiving Statements of Comparability, sponsored by Wychavon District Council which organised the event.

This was followed by a NHS Careers Fair for Refugees in Sheffield. 'We spoke to over 200 people at this event alone,' said Alina Davodova. 'There was huge interest in the vital role UK ENIC can play in helping refugees and asylum seekers convert their qualifications into meaningful career prospects.

'Many of those we spoke with were gratified to learn that there was a way for them to have their qualifications recognised in the UK.' READ MORE
