The agreement was signed in an online ceremony on 6 January by Paul Norris, Head of UK ENIC, and Professor Dato Mohammad Shatar Sabran, MQA CEO [pictured above centre], who will be joining our UKENIC22 conference in London on Monday 20 February. Prof Ir Khairul Salleh Mohamed Sahari, MQA Deputy CEO, will also be at our conference.

Paul Norris speaks at international forum on recognition in Azerbaijan



An International Forum on the Recognition of Foreign Higher Education Qualifications and Prior Learning took place in Azerbaijan in December. It was hosted in Baku by the country's Education Quality Assurance



Two members of staff from the Malaysian Qualifications Agency (MQA) travelled to the UK earlier this month for a successful week-long training and shadowing programme, in which we shared our experience and expertise in operating and running a qualification recognition function and a busy recognition centre.

The programme was designed and delivered tailored to meet the needs of the MQA, in the spirit of our renewed Memorandum of Understanding with them [see separate story].

We are pleased to share our knowledge and experience in this way, for the benefit of recognition agencies, qualifications authorities, and skills and education ministries worldwide. Pre-COVID, we hosted a number of international recognition and ministry teams at our UK HQ for these 'development weeks', but pandemic travel restrictions halted these. The visit of the MQA marks a resumption of these activities, as international travel reopens.

By visiting us and spending time with us at our Cheltenham centre, recognition agency and ministry teams can work alongside our own expert staff, gaining insight into the detail and practicalities of how applications, enquiries, and processes are handled and managed. They can see our computer systems and enquiry systems in situ for themselves, speak to our staff and managers, ask questions, and exchange ideas. Knowledge gained can then be applied to the visiting team's own situation on return home.
