ENIC NORTH Conference, Glasgow, 19 May - Early Bird discount ends soon



Our ENIC NORTH face-to-face conference will take place on Thursday 19 May at the Technology and Innovation Centre, University of Strathclyde - in the centre of Glasgow, close to all transport links. More details of the conference programme are now available.

This one-day in-person event will preview the 'Shifting Balance, Changing Models' main theme of the UKENIC22 Annual Conference later in the year. In the context of world events, the pandemic, and changes in the global economy, ENIC NORTH will explore student admissions and recruitment, and how models are adapting, often digitally, to meet the evolving needs of the education sector.

The programme offers an opportunity to meet and make connections with like-minded professionals from across the education sector, and to address key topics of concern for higher education, FE, and professional bodies, with the perspective of the UK nations and regions and of Scotland in mind.

Impact of the UK-New Zealand Free Trade Agreement on recognition of qualifications

The UK and New Zealand signed a free trade agreement (FTA) on 28 February 2022.

Whilst not yet in force, the FTA covers professional qualifications and professional services in the Professional Services and Recognition of Professional Qualifications Annex.

The FTA provides for the establishment of recognition routes between the regulatory bodies in the UK and New Zealand, aiming to support professionals in having their qualifications recognised.
