# Building qualification recognition in the Gulf Cooperation Council countries



UK ENIC and Ecctis, together with the British Council, have been working in recent months on behalf of the UK Government to engage UK and Gulf Cooperation Council (GCC) stakeholders on issues of recognition of qualifications. Ongoing discussions aim to improve arrangements for recognition, agree areas of mutual interest and priority and, ultimately, pave the way for negotiated mutual recognition agreements.

Funded by the FCDO Gulf Strategy Fund, the initiative is part of wide-ranging efforts to build stronger and more dynamic links between the UK and the six GCC countries: the Kingdom of Bahrain, the State of Kuwait, the Sultanate of Oman, the State of Qatar, the Kingdom of Saudi Arabia and the United Arab Emirates.

The work seeks to facilitate positive developments in the areas of mobility and migration, and to support bilateral collaboration, partnerships, and recruitment for study and employment. READ MORE

# Paul Norris chairs ENIC-NARIC online workshop on micro-credential evaluation



An online workshop for ENIC-NARIC representatives to consider ways of evaluating micro-credentials was chaired by Paul Norris, Head of UK ENIC [pictured above, bottom right].

More than 50 people attended the event, which illustrated the different types of micro-credential, and offered evaluators new techniques for assessing these in line with the principles of the Lisbon Recognition Convention.

Three presentations featured in the 90-minute event:



Major upgrades to our web servers and internet hosting were carried out this month, with investment aimed at further enhancing our services to members and individual applicants.

This month's 'under the bonnet' IT development work saw us shift all of our websites and online services to new state-of-the-art cloud-based hosting, leading to faster website speeds and responsiveness for our users. The changes will also mean even better system resilience and security.

UK ENIC Head of IT, Nick Everett, says: 'The efficiency of our IT team's work in moving all of our web servers and databases to a cloud-native platform meant the work was completed with just 6 hours' weekend downtime, rather than the up-to-36 hours we had planned for. READ MORE

# New UK ENIC project to support refugee integration

In the first-ever round of grants from the Council of Europe to support ENICs in implementing best practices in recognition, UK ENIC has won a grant bid for a project to explore the impact of receiving a Statement of Comparability for refugee applicants.

The Tracking Refugee Applications for Study and Employment in the UK project (TRASE UK) will involve surveys of refugee applicants, as well as UK ENIC members, to find out

- how useful they found the information in their Statements
- whether further guidance could be provided to support them, and
- what use has been made recently of the European Qualifications Passport for Refugees (EQPR) in the UK.

The project supports the functioning of Article 7 of the Lisbon Recognition Convention on the recognition of qualifications held by refugees, displaced persons and persons in refugee-like situations. READ MORE
