Professional Qualifications Act receives Royal Assent

Professional Qualifications Act 2022

The Professional Qualifications Bill has received Royal Assent, and so has now become The Professional Qualifications Act 2022.

Dr Cloud Bai-Yun, Chief Executive of Ecctis, says: 'This is indeed a remarkable achievement. I am proud that UK ENIC and Ecctis expertise played an active and pivotal role in helping shape this important legislation, with w ork having begun long before it w as formally introduced to Parliament in May 2021.

'The Act sets out a UK-w ide framew ork for recognising professional qualifications held by people from right across the w orld, establishing a renew ed global focus for the future.'

Zara Green, Centre for Professional Qualifications Manager, reported that: 'Since its scope covers a range of professions, formative discussions included a number of UK Government departments, Devolved Administrations, and other stakeholders. The scope of this Act will ensure the continued close w orking betw een the Assistance Centre and the competent authorities responsible for regulating professions, benefiting future generations of mobile professionals through having clear procedures for the recognition of their professional qualifications.'

Looking back at our successful ENIC NORTH face-to-face conference





The UK Centre for Professional Qualifications (UK CPQ) has been working to assist Ukrainian refugees, with information and guidance on the recognition of professional qualifications. UK CPQ is seeing an increase in queries from those with Ukrainian qualifications, as well as their hosts under the *Homes for Ukraine* scheme.

UK CPQ can advise on w hether a professional requires a licence or registration in order to w ork in their profession in the UK, and can signpost applicants to the correct body to process their application for recognition. It can also advise on professions that are unregulated in the UK, and signpost applicants to the correct procedures to begin starting w ork or setting up a business.

UK CPQ has been working closely with professional regulators and the UK Government, providing information on procedures for the recognition of Ukrainian qualifications, and support for applicants with limited or partial documentation. The importance of this work has been further highlighted by recent UK Home Office data indicating rising UK acceptance rates of asylum seekers from across the globe. READ MORE

Internationalisation opportunities in Jordan, Lebanon and Syria: guidance for HEIs

New resources are now available from the PELIARQ project (Promoting European-Levantine Internationalisation and Automatic Recognition of Qualifications), which is funded by the Erasmus+ programme, and which aims to strengthen ties betw een institutions in Europe and the Levant region.

An online guidance toolkit for higher education bodies to learn about opportunities for internationalisation links with HEIs in Jordan, Lebanon and Syria, has been launched, with accompanying guidance on the region's education and credit systems, and qualifications framew orks.

Alongside partners UNIMED and NARIC Malta (MFHEA), the team has developed guidance on current internationalisation activities and mobility placement opportunities, details of past projects and inspiring examples. There are additional resources for HEIs looking to establish partnerships and links through a variety of international activities betw een Europe and the Levant.

An online event w as hosted by UNIMED on 25 May, and this w ill be follow ed by tw o in-person events: in Amman, Jordan on 22 June, and in London on 29 June. The conference opened with a plenary featuring Professor James Miller, Deputy Vice Chancellor of Glasgow Caledonian University; Chris Stephens, Head of Commercial Division, UK ENIC; and Stuart Rennie, SJRENNIE Consulting.

Professor Miller made the keynote speech, in w hich he addressed the topic: 'How the past two years could have shaped the next tw enty'. He posed a series of questions to delegates, including:

- How will your university respond to the longer term need for innovation in pedagogy?
- What will your university's value proposition be to this and to the next generation of students?
- What impact will the environmental sustainability agenda have on the approach to international mobility of individual students and of universities?
- What longer term teaching and research partnerships will emerge from our new connections in Ukraine?

Follow ing this plenary, delegates took part in a series of thought-provoking breakout sessions, enabling them to meet and make connections with like-minded professionals from across the education sector.

UK ENIC to review new Latvian secondary school diploma



Anita Muizniece, Minister for Education and Science for Latvia, *[pictured above, front centre]* met with representatives of the UK Department for Education and UK ENIC to discuss study options for Latvian secondary school graduates at UK universities.

The Latvian school system has been undergoing reform, with the first cohort due to take their final upper secondary exams in Spring 2023.

UK ENIC has pledged to assist these students by explaining the new Latvian secondary qualification to universities and other members among our networks. We will undertake a review of the new curricula and exams, sharing initial findings with our members and stakeholders in advance of the first cohort to support them in assessing applications for undergraduate admissions.
