UKNARIC17: Charting the course ahead; achieve growth, control risk

Next week over 500 delegates will be joining us for the biggest ever UK NARIC annual conference. UKNARIC17, at London's Park Plaza Victoria, will be an exciting opportunity for delegates to get the latest information and ideas, network and build future partnerships.

Developing working relationships and promoting growth is an important theme of this year's conference, and a number of key international speakers will be running workshops [pdf] and networking with delegates.

Notably, we will be welcoming Dr Mohd Nor Azman Hassan, Deputy Director General of Malaysia's Ministry of Higher Education. Recent changes to Malaysian educational frameworks to aid international partnerships create a favourable environment for collaborations, and UK NARIC's Global Connect team will be on site to make introductions and facilitate conversations.

We will also be joined by Guangcai Dong, of Liaoning Normal University, leader of the Expert Advisory Group of the UK-China AIR programme to foster teamwork between UK and Chinese universities in vocational education, who will be leading a workshop for institutions interested in developing partnerships and courses.

Given UK NARIC's depth of knowledge and understanding of the data involved in comparing and benchmarking qualifications we are now moving forward to offer more specific and targeted uses of our information.

By developing more interpretive indicators such as IEQ and PHER we are offering much richer and more nuanced insights into student behaviours and outcomes, enabling admissions teams and strategists to recruit students who are more suitable and able for their specific courses. This 'third generation' recognition goes beyond qualification-to-qualification and framework-to-framework comparison, and is strategically valuable to course developers and marketing teams to guide their planning.(more...)

UK NARIC signs Memorandum of Collaboration with China Hi-Tech Group

UK NARIC and the China Hi-Tech Group are strengthening their relationship with the signing of a Memorandum of Collaboration. The document was signed by Tao Yin, CEO of China Hi-Tech Group and Dr Cloud Bai-Yun, CEO of UK NARIC on 24 October in Beijing (*pictured above*).

The signing of the agreement represents a new phase of cooperation between the two organisations, to facilitate international education partnership opportunities across the region for UK NARIC members, to benchmark qualifications, and to raise standards in key sectors including Nursing, Early Education and Teaching.

China Hi-Tech Group is an education investment and development group, initiated by the Chinese Ministry of Education and established in June 1992 by more than 60 major universities in China. Now a public company, the China Hi-Tech Group has 19 shareholders, almost all of which are highly selective and respected universities in China, with the Chinese Ministry of Education as the controlling shareholder.

China Hi-Tech Group plays a key role in the development of degree-granting vocational education and career training programs in the education and skills sector. UK NARIC's expertise in international qualifications will provide the critical support (more...)

The study examines the progression and performance of international students entering UK undergraduate programmes with qualifications that have not traditionally allowed automatic entry to Bachelor courses.
