

## Enquiries statistics show no post-referendum shifts

UK NARIC presents the sixth edition of our quarterly statistics series, covering July to September 2016.

There are no noticeable shifts in the individual enquiries data 'post-referendum'. There is no discernible evidence in this third quarter of any dramatic drops (for example, in enquiries from EU countries), nor of falls in individual enquiries overall.

The top 6 countries this quarter remained consistent, with no change in ranking through the quarter, and this top 6 is the same as in quarter 2.
