Next week, a record-breaking 600-plus people are scheduled to attend the biggest-ever UK NARIC annual conference on 7 and 8 November.

UK NARIC, Cambridge Assessment English host HE conference on Brexit

UK NARIC, in collaboration with Cambridge Assessment English, hosted in London a conference for higher education to discuss the current opportunities and challenges in the recruitment of international students.

Representatives from more than 60 universities came together to hear and discuss the latest research, developments and debates within the sector, focusing particularly on Brexit and the growing trend for universities in Europe to deliver courses taught entirely in English.

UK NARIC CEO signs MoU on International Vocational Education Initiative in Beijing

The CEO of UK NARIC, Dr Cloud Bai-Yun, has signed in Beijing a Memorandum of Understanding [*pictured above*] with the Tao Xingzhi Committee for the Belt and Road International Vocational Education Initiative.

Also launched at an event in Beijing attended by UK universities and Chinese colleges was a new alliance: The UK and China's Modern Apprenticeship and Education Cooperation Alliance.

Dr Bai-Yun has been made honorary chair of the new alliance, which aims to facilitate cooperation between UK institutions and Chinese vocational colleges.

The UK NARIC quarterly statistics series: July to September 2018

UK NARIC presents the fourteenth edition of our quarterly statistics series, covering July to September, 2018.

This shows movements in numbers of completed UK NARIC individual enquiries, by country. The data are shown in the tables after the link.

Notable features include: Looking at completed enquiries as a percentage of country population, Trinidad and Tobago rose from a top 70 position to rank in the top 10 in September. Macedonia dropped out of the top 20 in this table after maintaining its position throughout May, June and July.

In the table for total completed enquiries, Ghana maintained a 16th place throughout the quarter. ([more...](#))
