50 new countries being added to UK NARIC certificate bank

Welcome to the September 2017 edition of NARIC News

As part of our Information Development plan, *(infographic below)* the UK NARIC certificate bank is increasing in size by almost 50%, as scans of certificates from 50 new countries are currently being added to the existing bank of over 3,500 high resolution images of certificates.

Once these go live later this year, the database will hold upper secondary and undergraduate awards certificates from more than 154 countries around the world, enabling members to visually check documents offered to support an application.

This upgrade makes the certificate bank an even more useful tool for fraud prevention and maintaining compliance with Tier 4 student visa requirements.

Access to the certificate bank is included in all Level 3 and above membership packages. If you need access, or if you have any problems, please call your account manager or contact member services. It is possible to arrange free trials of the certificate bank or extensions to packages to give access to the bank. (more...)
