Strong speaker line-up announced for UKENIC23 annual conference: London, 4 and 5 December



Ajaz Ahmed, entrepreneur, author and CEO of ideas and innovation company, AKQA, will be one of the keynote speakers at the UKENIC23 annual conference, which takes place at The Queen Elizabeth II Centre, Westminster, London, on 4 and 5 December.

In an interview-style opening plenary session, Tom Bewick, CEO of Ecctis, the operating company of UK ENIC, will talk with Ajaz, whose books include Velocity - The Seven New Laws for a World Gone Digital.

The overarching theme for UKENIC23 is 'Reconfiguration', with a programme offering a choice of over 40 sessions, including two plenaries.

Developing closer links between India and the UK higher education sectors will be among the current and relevant topics covered.

A discussion panel featuring Dr Pankaj Mittal, Secretary General of the Association of Indian Universities, will consider what the Memorandum of Understanding on India-UK Mutual Recognition of Academic Qualifications means for universities, colleges and professional bodies, and the prospects for educational collaborations and partnerships.

Conference content will include practical advice, case studies, intelligence, and analysis for strategy and development. There will be excellent networking opportunities with attendees including delegations from India and China.

UK ENIC participation in India-UK Higher Education Conference in Delhi



UK ENIC participated in the India-UK Higher Education Conference in Delhi on 18 and 19 September, hosted by the British Council.

UK ENIC Global Partnerships Manager, Henry Huggett, delivered a presentation on the latest developments on India-UK mutual recognition to conference attendees, which included representatives from over 30 UK universities, the largest delegation of UK universities ever to visit India. Delegates from both India and the UK gave their perspectives on the benefits and challenges of mutual recognition, and discussed possible barriers and opportunities in India-UK transnational education (TNE).

Professor Sir Steve Smith, UK International Education Champion, and Neeta Prasad, Joint Secretary, Ministry of Education, India, addressed the conference's opening session.

In the days following the event, Henry Huggett and Dr Cloud Bai-Yun, Chief Adviser to UK ENIC, held further meetings with Association of Indian Universities (AIU) representatives. These developed our close working relationship with the AIU on the implementation of the Memorandum of Understanding on India-UK Mutual Recognition of Academic Qualifications.
